





Mission Shakti Group (MSG)/ALF/Rag pickers Groups shall take the following responsibilities and Provide required Manpower & Machinery equipment and executing the same for processing of waste for Bio-mining of Legacy waste at Kenduguda, KOTPAD NAC.

1. The terms of proposal are valid for One year from the date of execution of agreement.
2. The MSG/ALF/Rag picker Groups shall provide required manpower & Machinery/ equipment and execute the same in a time bound manner.
3. The MSG/ALF/Rag picker Groups shall provide required personal protective equipment's to the engaged Workers at processing area.
4. The MSG/ALF/Rag picker Groups will be held responsible for any loss, damage or theft of equipment.
5. If the Processing work is found unsatisfactory, then the MSG/ALF/Rag picker Groups will be terminated from the work one-month prior notice.
6. The selected WSHG/ALF/Rag picker Groups will be completely responsible for any kind of damage/loss of property/machinery related issue.

Payment to MSG/ALF/Rag picker Groups

1. The engaged Labor shall be provided with minimum wages as per rates prescribed by the Labor Department.


