2. SCOPE OF WORK

The successful bidder shall be responsible for:

- Marketing, managing, and selling advertising space on the LED display board.
- Maintaining the LED display board in working condition.
- Ensuring the advertisements comply with municipal regulations and guidelines.
- Revenue collection and timely remittance of payments to the authority.
- Submission of periodic reports on advertising activities.

3. ELIGIBILITY CRITERIA

To participate in this tender, bidders must:

- i. Be a registered entity with valid TIN such as GST & PAN No.
- ii. Have prior experience managing advertising on digital/LED display boards will be given preference.

4. EVALUATION CRITERIA

The NAC Kotpad will evaluate and compare the quotations determined to be substantially responsive i.e. which (a) are properly signed and (b) confirm to the terms and conditions. Past work experience in this regard will be given preference.

5. AWARD OF CONTRACT

- i. The work order will be awarded to the bidder whose quotation has been determined to be substantially responsive with highest quotation price.
- **ii.** The bidder whose bid is accepted will be notified towards award of contract by this NAC within 7 days. The terms of the accepted offer shall be incorporated in the work order.
- **iii.** The Electricity Connection will be provided from the NAC for operation of the LED Digital Outdoor Video and the energy charges will be borne by the Bidder separately.
 - **6.** Any effort by a bidder to influence the purchaser in its decision on bid evaluation or placement of work order may result in rejection of the bidder's offer.
 - 7. Any legal dispute out of this subject to Koraput District jurisdiction only.
 - 8. Notwithstanding the above, the undersigned reserves the right to accept or reject any quotation and to cancel the bidding process and reject all bids at any time prior to the issue of contract letter.
 - 9. A maximum of two hours shall be reserved for NAC Kotpad and Government advertisement purposes at a time designated by the Executive Officer, NAC Kotpad which will be communicated from time to time. If no such time is intimated, the agency may utilize the time as needed.
 - 10. Before issuance of work order, the selected bidder shall deposit a demand draft in favour of the Executive Officer, NAC Kotpad, payable at Kotpad for an amount equivalent to 03 (Three) monthly advertisement fees of the contract value (as quoted by the bidder).
